Sustainability Policy

1. Context

Marino Institute of Education (MIE) is an important third level education provider located in Griffith Avenue, and the MIE campus contributes to the environment¹ and character of the Marino area. As an educational institution it has a role in, and a responsibility to, society to promote sustainability and sustainable development² throughout all its activities both academic and institutional. This means that teaching, research, services, building development and administrative operations should be conducted in a manner that protects and enhances the environment¹, conserves and restores natural resources, reduces greenhouse gas emissions, and supports the community and society as a whole.

2. Purpose

The purpose of this policy is to establish the underlying principles of sustainable development that inform the conduct of MIE in all its activities.

3. Benefits

This policy articulates the values and principles of MIE and its interaction with its environment¹.

4. Principles

MIE is committed to:

- Balanced development with regard to the environment, economy and society;
- Demonstrating leadership in terms of our environmental sustainability practices;
- Managing and operating its campus in a manner that protects and enhances the local and global environment by establishing quantitative goals for environmental performance and sustainability;

- Working to reduce greenhouse gas emissions;
- Promoting intelligent resource use, namely sustainable transport use, minimisation
 and reuse of products/materials, green procurement, sustainable catering, recycling of
 waste streams, energy efficiency, renewable energy and water conservation;
- Incorporating the principle of sustainability and sustainable development into the induction, teaching, training and research activities of the Institute insofar as possible;
- Development of sustainability funding for use by departments, staff and students to support on-campus sustainability initiatives and innovations;
- Continuous environmental improvement, including pollution prevention throughout its activities and compliance with all relevant legislation in the area.

- Energy conservation measures⁴

5. Responsibility

The President of MIE is responsible for this policy. This policy will be actively communicated and promoted to staff, students, contractors and visitors. Progress and implementation will be reviewed on an annual basis, also subject to a comprehensive review every three years.
